

**SITI Company
Training Spring 2010
SCHOLARSHIP GUIDELINES**

Eligibility Requirements:

- Applicants must have prior training experience with SITI Company.
- Applicants must demonstrate financial need. Only applicants earning less than \$30K in yearly income (in the previous tax year) will be considered. You must be able to verify proof of income through tax return or other documentation.
- Applicants must apply for and be accepted into training program.
- Applicants cannot be currently enrolled in a college or university training program.

Quick Facts:

- Scholarships are awarded on a need and merit basis, and at the discretion of SITI Company teaching artists and staff.
- Scholarship aid is not guaranteed. Approximately 2 eligible students per session will receive scholarships.
- Scholarships may cover up to 50% of tuition costs.
- Scholarship aid may only be applied to tuition expenses.
- Only complete applications of those meeting the eligibility requirements will be considered.
- The Application DEADLINE for the Spring 2010 session is Monday, March 1.

Application Instructions:

- Complete your application for the current Training session. You must submit the minimum non-refundable deposit amount in order to secure your slot (\$100 for the Spring 2010 session). In your brief statement describing your experience, please indicate your intention to apply for scholarship aid.
- Submit the following via postal mail OR email:
 - Application Cover Sheet (see attached)
 - A monthly budget (see attached)
 - A copy of pages 1 and 2 of your most recent federal income tax return. If you are an international student, please indicate your country of origin and provide proof of your annual income.
